#### Remarks:

According to the 2021 share option incentive scheme, the Company intended to grant 5,947,858 share options. On 18 November 2021, the general meeting resolved to grant 5,353,072 share options to 289 Participants while the remaining 594,786 share options will be reserved for further granting in the future. On 19 November 2021, pursuant to the mandate of the general meeting, the Company convened board meeting to make adjustment to the list of participants of the first grant and number of the share option. After such adjustments, the number of participants of the scheme is adjusted from 289 to 288, and the number of share options granted of 5,947,858 remains unchanged, of which the number of the first grant of share options is adjusted from 5,353,072 to 5,341,072 while the number of the reserved share options is adjusted from 594,786 to 606,786. As such, board meeting granted 5,341,072 share options to 288 Participants under the first grant. Before completion of registration of the share options on 13 January 2022, 5 Participants gave up, resulting the adjusted number of participants as 283 with the adjusted first grant of share options.
